Objectives and Investment Policy

The investment objective of the Fund is to focus on providing income, with a minimum income return of 3% per annum, and also to provide capital growth consistent with this primary objective over the long term. Long term means over a minimum investment horizon of five years. The Investment Adviser expects to invest more than 50% of the Fund in collective investment schemes with exposure of the Fund typically between 20 – 60% allocated to equities and between 30 – 50% to fixed income securities, selected in accordance with the Investment Adviser's "thoughtful investor" approach (as set out in the Investment Approach below). The Fund may also invest in transferable securities such as shares and bonds (both quoted and unquoted), money market instruments, deposits, warrants, cash and near cash. The Fund may invest in shares or units of collective investment schemes which are managed or operated by the ACD or an associate of the ACD ("Related Funds"). The Fund may also use derivatives and forward transactions for investment purposes or efficient portfolio management (including hedging). The use of derivatives for these purposes is expected to be limited however it may affect the volatility or risk profile of the Fund although this is not the ACD's intention. Investors will be given 60 days' notice prior to the Fund using derivatives for investment purposes.

Investment Approach

To select investments offering opportunities for capital growth over the long-term, the Investment Adviser applies its proprietary "thoughtful investor" investment approach, developed in tandem with its clients, which comprises:

1. the application of exclusionary screens, where possible;
2. applying the Investment Adviser's proprietary B.E.S.T. framework; and
3. ongoing stewardship activities.

Exclusionary screens

Where the Fund invests directly in transferable securities such as shares and bonds (both quoted or unquoted), the Fund will not invest in any enterprise or company if more than 10% of its revenues or profits (whichever is the greater figure) derive from:

- manufacture and distribution of weapons and related systems • nuclear military exposure • nuclear power generation • mis-marketing of infant milk formula • extraction or processing of fossil fuels • production and retailing of fur products • animal testing
- manufacture and retailing of alcohol • gambling • pornography • tobacco • high interest-rate lending • mining.

Where the Fund invests in Related Funds to which the Investment Adviser is appointed ("Adviser Funds"), the Investment Adviser ensure such collective investment schemes apply the same exclusionary screens. Where the Fund invests in shares or units of collective investment schemes which are not Related Funds or Adviser Funds, the Investment Manager is not able to ensure such collective investment schemes apply the same exclusionary screens. However, the Investment Adviser will not invest in collective investment schemes that do not apply some form of exclusionary screening, where such a screen would be relevant to type of assets invested in.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

- The investments of the Company are subject to normal market fluctuations and other risks inherent in investing in securities. - Liquidity risk: during difficult market conditions some securities, such as structured investments, corporate bonds and positions in emerging markets, may become more difficult to sell at a desired price.

- Operational risk: arising from investments in overseas markets, in particular emerging markets countries, which may not have the same level of safekeeping and other controls as UK markets.

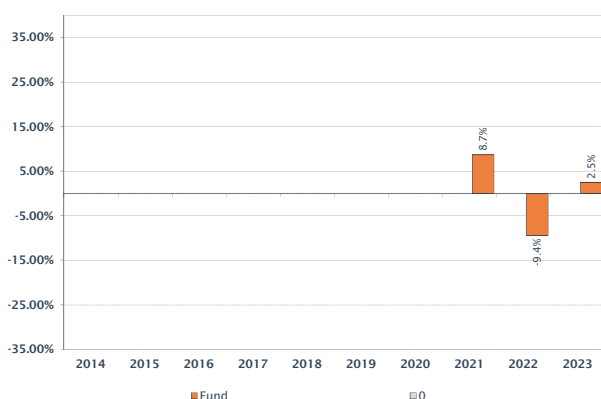
